Corral de Tierra Country Club - Golf Course Etiquette



GOLF COURSE ETIQUETTE

Please replace all divots. Rake or smooth out sand in bunkers after playing out. Repair ball marks (plus one more). Stay up with the group ahead. Faster groups should be allowed to play through if the situation dictates, regardless of size.



DRESS CODE

Corral de Tierra Country Club maintains strict policies on dress code. (Refer to the Dress Code Policy in this packet.)

Corral de Tierra Country Club ask that guests use the appropriate Locker Room located on the lower level of the Clubhouse for changing their attire. Changing footwear in the parking lot is not encouraged.



ELECTRONIC DEVICES

Cell phones and all electronic devices, including Blackberries and iPods, are only permitted in certain locations at the Club. You may use such devices within the confines of your vehicle or in designated rooms in the Clubhouse, and only for emergencies on the golf courses. Please ask one of our employees for assistance in finding these rooms. If you receive a telephone call while in the Clubhouse, please take the call outside of the building.



SMOKING

Corral de Tierra Country Club has a no-smoking policy throughout the entire Clubhouse.

DRESS CODE POLICY

Clubhouse

Country Club casual is acceptable, except for special events that have a defined dress requirement. Golfing attire is acceptable. **Shirts must either have collars or have a turtle or mock neck and be tucked in. Men's and women's shirts or blouses (Tommy Bahamas) that are designed to be worn outside trousers, slacks or skirts are acceptable.** All women's tennis attire worn under warm-up suits until 5:00 p.m. is acceptable. Footwear must be worn. **Men are not permitted to wear hats or caps inside the Clubhouse.** The Denim Rule is as follows:

Men and Women: Jeans or denim apparel of any style, color or design are permitted throughout the clubhouse and must be tasteful and in good condition (no rips, tears or holes).

Unacceptable Attire: No cargo pants or cargo shorts for men, short shorts or cut-off pants, swimming attire, flip-flops, sweat suits, stretch pants, tanks, mesh, halters or bare midriff tops, t-shirts, men's hats and visors.

Golf Course, Golf Shop and Practice Facilities

Proper attire on the Golf Course and Practice Facilities and in the Golf Shop is expected to conform in style to that which is sold in the Corral de Tierra Country Club Golf Shop. **Inappropriately dressed golfers shall be asked to change before playing.**

Acceptable Attire:

- Golf shorts and skirts no shorter than 6" above the knee or having at least a 7" inseam
- Collared shirts for men with a minimum width of 1 3/4" sleeve
- **All shirts must be tucked in with the exception of Tommy Bahama's.**
- Billed hats and visors must be worn with the bill forward.
- Golf shoes or appropriate footwear must also be worn at all times.

Golf Course Denim Rule

Men: **No** jeans or denim apparel of any style, color or design are permitted on the Golf Course or Practice Facilities.

Women: Jeans or denim apparel of any color **other than BLUE** are permitted on the Golf Course or Practice Facilities.

Unacceptable Attire: Head bands and bandanas, swimming attire, warm up pants and sweat suits, stretch pants, tank, mesh, halter, strapless or bare midriff tops, tennis attire, athletic attire, cut-off pants, t-shirts, cargo pants or shorts for men, metal spikes are not permitted.

Corral de Tierra Country Club Dress Code Enforcement Policy

The purpose of our dress code is to provide Members and their guests with a guide to appropriate dress when visiting Corral de Tierra Country Club. The Dress Code is applicable to all Members, guests and children while on Club premises. Club Members shall be responsible for their guests' adherence to the Dress Code at all times. Club personnel shall be expected to know the Dress Code and assist with enforcing its provisions by promptly informing Club Members of any violation(s) by any member(s) of their party. Any violation that is not resolved at the time of the incident shall be reported to the General Manager/COO for further action. The Member in violation will be given a Courtesy Dress Code Notice Card at the time of the incident or receive a letter from the General Manager/COO noting the violation. Repeated violations of the Dress Code will subject the Member to disciplinary measures under Article XI, Section 4 of the Bylaws. When a Member or their guests are in violation of the dress code the following disciplinary action will occur:

1 st Offense	Receive a Written Notice or Dress Code Courtesy Card
2 nd Offense	Receive a Written Notice or Dress Code Courtesy Card and \$50 Fine
3 rd Offense	Receive a Written Notice or Dress Code Courtesy Card and \$100 Fine
4 th Offense	Two Week Suspension
