Tour Policy & Procedures 2020

Does not apply to the North Monterey County Caravan

A \$25.00 fine may be assessed to an MLS Participant or Subscriber if a violation of the following Caravan/Tour Policy and Procedures is reported.

Should the fine not be paid within one week and/or should the violation(s) continue, an agent may lose their privilege of continuing to place properties on tour.

Home must be submitted on MCAR tour in the MLS by 3:00 pm the day before.

MCAR posts the Tour on the MCAR website by 8:00am the day of the tour.

(Real Estate offices download tour at various times)

1. New listing shall be opened no more than two times in the 1st month and only once a month thereafter.
2. An agent or representative of the agent **MUST be present** at the home for the **ENTIRE** time of tour.
3. Vacant homes may be placed on tour unattended with the provision that **“No REALTOR® in Attendance”** shall be indicated in bold print in the tour remarks area.
4. An agent, with the request of a seller or tenant may place a home on tour for a partial amount of time. A note stating that it is the sellers or tenants preference **MUST** appear in the remarks area.
5. The “OFFICIAL” time for submitting or canceling tour property is 5:00 p.m. the day preceding tour. Please note cancellations must be called to the M.C.A.R. office and a note must be left at the property.
